

Exhibitor Insurance Requirements

DEADLINE: FRIDAY, January 8, 2027

Who is required to submit insurance:

- All exhibit spaces including Space only booths, Turnkey Booths, Meeting Pods, Startup Kiosks, private meeting room sponsors

All insurance certificates must be submitted to Rainprotection by January 8, 2027.

If you decide not to purchase Rainprotection but instead use your own insurance, please make it complaint and then submit a copy directly to: PORTAL@Rainprotection.net. **COIs submitted directly to Logistics will NOT be accepted**

Robots and Vehicles: Please let your Sponsor Logistics Lead know if you plan to bring a robot or vehicle into your exhibit space as this may require additional approvals and COIs.

Activations and Games: Activations and games which involve a physical risk, run by a third party, or medical/health services, may require additional insurance. Make sure you communicate any special activations or games to your logistics lead.

COI Requirements: Per the [Exhibitor Terms & Conditions](#) Exhibitor and its independent contractors, at their sole expense, shall obtain and maintain during the Event insurance coverage and provide Fintech Meetup with a certificate of insurance (reasonably acceptable to Fintech Meetup) and applicable additional insured endorsements at least thirty (30) days prior to use of the premises as follows: (a) Worker's Compensation Insurance as required by local or state law; (b) Commercial General Liability Insurance (including but not limited to blanket contractual liability and personal and advertising injury coverage) with minimum limits of at least \$1,000,000 in any one occurrence and \$3,000,000 in the aggregate. This insurance must be in force during the dates of February 22nd - February 24th, 2027, naming Fintech Meetup (605 Third Ave., 26th Floor, New York, NY, 10158) as the certificate holder. The following must be named as additional insured: Fintech Meetup, Pioneer OpCo, LLC, Expo and Convention Center LLC, Venetian Las Vegas Gaming, LLC, Grand Canal Shops II, LLC, and The Shoppes at The Palazzo, LLC and their parent company, affiliates, subsidiaries, successors and assigns, and all of their directors, officers, employees, and agents ("Additional Insureds") as Additional Insureds (except for Worker's Compensation), and the policies will be primary and non-contributory, and waiver of subrogation will be in favor of the Additional Insureds.

External Approved Contractor Insurance Requirements

DEADLINE: FRIDAY, January 8, 2027

Who is required to submit insurance:

- All External Approved Contractors (EAC) and Subcontractors are required to submit their Certificate of Insurance to logistics@fintechmeetup.com. Contractors without a COI will not be permitted to build in the exhibit hall.

All insurance certificates must be submitted to logistics@fintechmeetup.com by January 8, 2027.

Robots and Vehicles: Please let your Sponsor Logistics Lead know if you plan to build a robot or vehicle into your exhibit space. If an automobile is a part of the booth build you need to inform the Sponsor Logistics team by **December 18th 2026**. Automobiles need to get approval from the Fire Marshall.

Automobile Insurance: Please make sure your COI includes Automobile Liability Insurance of at least \$1 million per occurrence. Or submit a separate proof of valid auto policy.

COI Requirements: Per the [Exhibitor Terms & Conditions](#) Exhibitor and its independent contractors, at their sole expense, shall obtain and maintain during the Event insurance coverage and provide Fintech Meetup with a certificate of insurance (reasonably acceptable to Fintech Meetup) and applicable additional insured endorsements at least thirty (30) days prior to use of the premises as follows: (a) Worker's Compensation Insurance as required by local or state law; (b) Commercial General Liability Insurance (including but not limited to blanket contractual liability and personal and advertising injury coverage) with minimum limits of at least \$1,000,000 in any one occurrence and \$3,000,000 in the aggregate.
